"Conflict Minerals" Statement - January 2015

Introduction & Definitions

"Conflict Minerals" are defined as those mined in areas of armed conflict and human rights abuses, and which are sold or traded by armed groups. The Democratic Republic of Congo (DRC) and adjoining countries were identified as conflict areas of particular concern. In August 2012, the United States Securities & Exchange Commission (SEC) issued a Final Rule in relation to Section 1502 of the Dodd-Frank Wall Street Reform & Consumer Protection Act. This rule placed new disclosure and reporting obligations for companies listed on the SEC in relation to "Conflict Minerals". In order to meet these obligations, SEC-listed companies require the co-operation of their supply chain partners. "Conflict Minerals" and the adjoining "Covered Countries" i.e. those sharing an internationally recognised border with the DRC (previously referred to as "DRC Countries") are defined in the Act as follows:

Mineral	Description	Covered Countries
Cassiterite	Ore from which Tin is extracted	Democratic Republic of Congo Angola Burundi Central African Republic The Republic of the Congo Rwanda South Sudan Tanzania Uganda Zambia
Columbite-tantalite	Ore from which Tantalum is extracted	
Gold	Rare metal found in a native pure form and obtained as a by-product of other mining operations	
Wolframite	Ore from which Tungsten is extracted	

Products containing "Conflict Minerals" derived from recycled or scrap sources are considered to be "DRC Conflict Free" under the Act.
